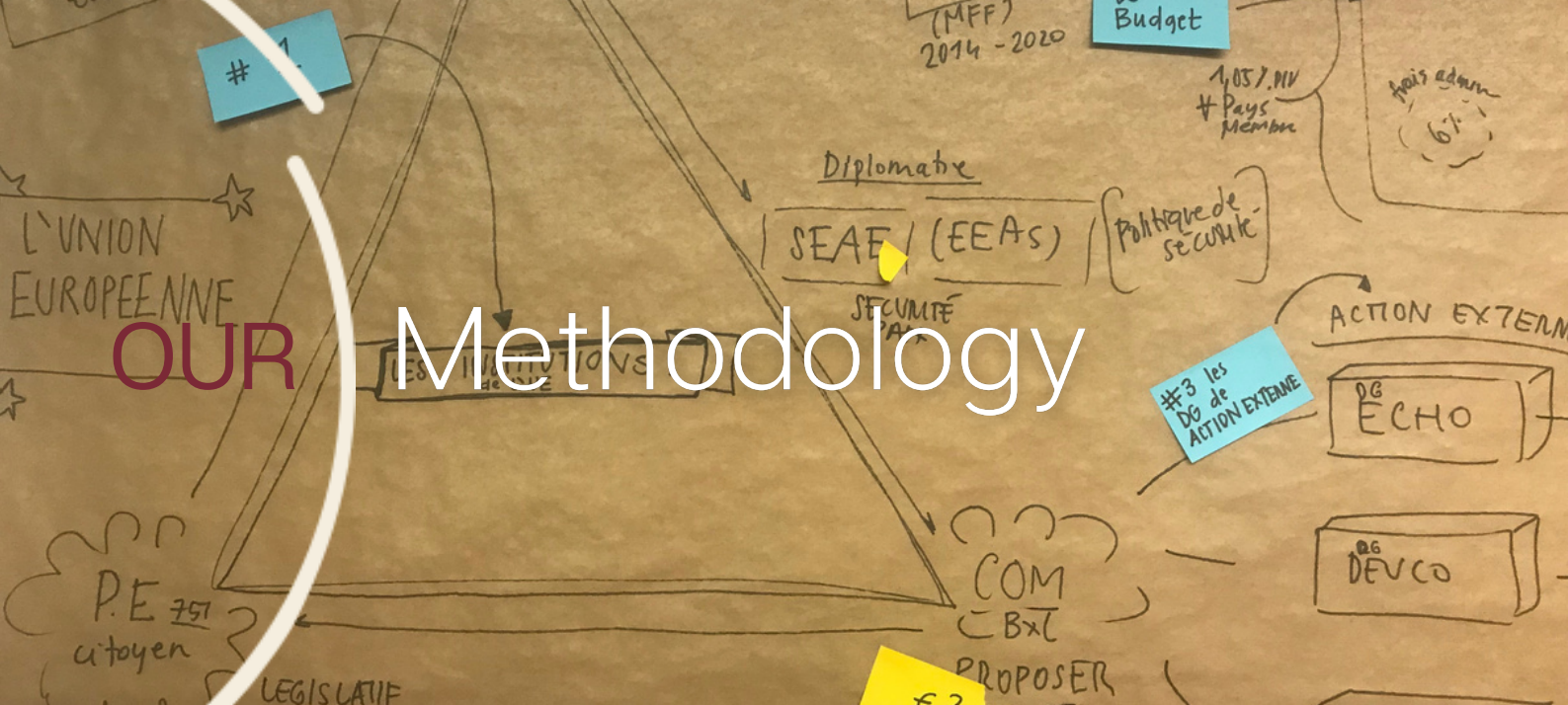
A learning hub for international cooperation and humanitarian aid programmes.

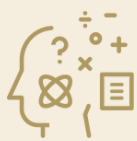

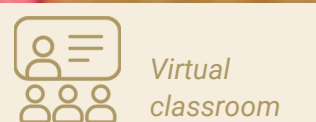


Get EU Grants: writing successful proposals

This course provides **practical guidance** on how to prepare **compelling project proposals** and obtain funding from the EU for development cooperation programs.

It explores the **EU funding and programming system** and how to establish a **fruitful relationship** with the EC and the EU delegations. It focuses on how to deal with calls for proposals and on the **information to be provided** at each stage of the application process (i.e. concept note and full application). Finally, it allows participants to get tips from PuntoSud experts on how to draft a realistic **budget**, in line with the EU requirements.

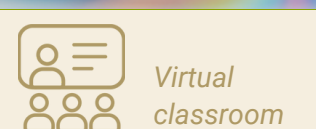

Financial management of EU Grants

This course covers everything you need to know about the financial management of EU-funded projects starting from the preparation of a **suitable and realistic budget** and a **procurement plan**, in compliance with EU applicable rules. The course also aims to enhance participants' knowledge and tools for **monitoring project expenditure** to ensure the **eligibility** of all the costs and the collection of all needed **supporting documents**. Moreover, it focuses on how to manage **budget modifications** and draft **financial reports**. Finally, it seeks to help organisations to properly prepare and deal with **expenditure verifications** and possible **audits**.

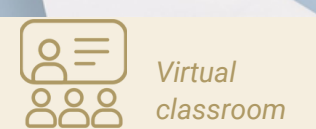

Result-based planning and management

In the last 30 years, manuals and donor guidelines have been making a great effort to introduce different planning & management methods, like ZOPP, RBM, Logframe Approach, ToC, etc. The question is **'what should we do today' with this massive theoretical evolution?**. The course aims to respond to this question by providing an overview of the most common planning & management methods and by accompanying participants in **linking PCM, RBM and ToC**, for the benefit of **clear evidence of project achievements and of change**.

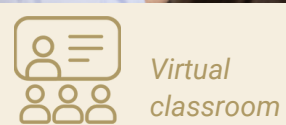

Monitoring and Evaluation in EU funded projects

This course guides participants through the set up and management of **M&E systems** within EU-funded projects. It provides practical tips and step-by-step guidance for the development of adequate **M&E tools**, starting from a good logframe with relevant and measurable indicators. It focuses on the **methods of collection, analysis and use of data** to make sure the action is on track and achieves the expected results. It goes through the **different types of M&E exercises** and discloses how to prepare relevant **Terms of References**. Finally, it shows how M&E can feed the organisation' **reporting, communication and learning processes**.

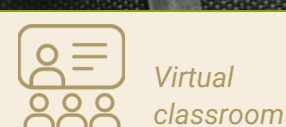

Reporting on the implementation of EU Grants

This course discloses all the aspects related to reporting on EU Grants **according to the PRAG rules**. It focuses on the main **EU requirements, deadline and templates** for the preparation of **narrative reports**, keeping focused on results, responding to the EU expectations and communicating all the occurred changes in a proper way. The course shows also the **steps** to be followed to **prepare accurate financial reports** and to provide the needed information related to project expenditure. Finally, it clearly explains the **EU payment procedures and currency conversion rules** and practices for reporting.

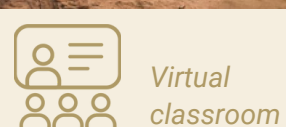

Managing ECHO Humanitarian Actions

This course is focused on the **European Union Humanitarian Aid Action** and its main objectives. It provides in-depth and practical knowledge about the **Partnership 2021 – 2027 and its main provisions**. Part of the course is dedicated to the logic behind the **Single Form format**, how to properly complete and submit it and **how to manage** (and report on) the ECHO funded action. The course finally aims at making participants able to ensure **compliance** with the donor's rules and an **adequate, effective, equitable and flexible delivery of aid**.

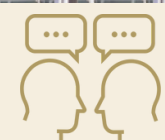

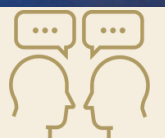

The course provides a specific and practical overview of **all the rules and procedures** applicable to EU Grants under the **PRAG**. It makes use of case studies, good and bad examples from the real life. The course aims at sharing **best practices practical experiences** also from the participants to solve all types of issues and challenges related to the implementation of EU-funded projects: e.g. **procurement**, procedures for possible **amendments, M&E tools**, ensuring **cost eligibility** and **EU visibility, reporting**. It also provides useful tips for establishing fruitful **partnership and coordination** mechanisms with the EC or EU delegations and other actors on the ground.

This course provides all the information needed to **design, select, award, manage, monitor and report** on financial support to third parties.

It provides for download the **formats and the templates** (developed by PuntoSud) that are needed in each phase of the process (e.g. Guidelines for applicants of a call for proposals, formats to be used by the third parties at proposal and reporting stages, contracts to be signed with the third parties).

Finally, it gives practical tips and tools to **ensure compliance** with EU applicable rules.

This course goes through the experience of a fictional NGO whose staff is going to face an expenditure verification and want to **avoid the risk of ineligibility** of costs.

It focuses on how an expenditure verification is conducted, what can be expected from auditors, how to ensure that all the required **information** and **supporting documents** are **available**, well **organised** and **compliant** with Auditors' requirements.

This course consists of a guide throughout the different phases of **procurement processes** in the framework of EU Grants.

It helps familiarising with **procurement principles** and terminology and shows how to translate them into practical procedures.

It goes through the essential steps of drafting procurement plans and **provides guidelines** and ready-to-use **checklists** and **templates** for the different procurement processes.



Creating and implementing an effective Code of Conduct

In the last years, the DG INTPA and DG NEAR gave grant applicants the possibility to present budgets including simplified cost options. The main aim is to simplify and **reduce administrative burdens**.
